A new owner will have the potential to earn a holding income while they wait for plans to be approved, with the parcel hosting an original three-storey block of four apartments. Held by the same owners for the past 30 years, they are now ready to divest the asset. Located just off Albatross Avenue, in a quiet cul-de-sac, the holding is in proximity to a host of amenities, including the Nobby Beach dining precinct and retail mecca of Pacific Fair in nearby Broadbeach.
